CALL FOR APPLICATIONS N° 007 - 202 CA/MINJEC/CAB OF THE 31 1111 2025 FOR THE SELECTION OF SEVENTY-NINE (79) YOUNG CAMEROONIANS TO BENEFIT FROM THE ACCOMPANYMENT, TOWARDS THEIR INTEGRATION IN THE TRANSPORT SECTOR THROUGH BIKE RIDING IN THE CITIES OF DOUALA AND YAOUNDE.

I. BACKGROUND AND RATIONAL

Following the very high accord of the President of the Republic at the invitation of the company YUNUS S.A., an inter-ministerial delegation (PRC, MINREX, MINJEC, AMBACAM BRUXELLES) sojourned in the Kingdom of Belgium from February 24 to March 3 2025. The objective of the trip was to close the youth month in the diaspora on the one hand and mobilize technical and financial partners towards their support to the empowerment of the Cameroonian youth through self-employment.

Within the framework of the implementation of its missions in terms of promotion of national integration and specifically of the monitoring and the accompaniment of local and diaspora initiatives in view of their contribution to nation building, the Ministry of Youth Affairs and Civic Education (MINJEC), during this trip, signed a tripartite Partnership Agreement with the Company YUNUS S.A and the financial institution PEOPLE Finance S.A (PEFI). The said agreement aims the accompaniment to the socio-economic integration of youths.

The objective in the execution of this agreement being on the one hand, to put at the disposal of young Cameroonians, motorbikes under the terms of a financial locative contract/conditional sale and on the other hand, to enable them create income generating activities. So is the rational of the present Call for Applications that targets the selection of seventy-nine (79) young Cameroonians willing to benefit from an opportunity in the transport sector through commercial bike riding.

II. PURPOSE OF THE CALL FOR APPLICATIONS

The present Call for Applications has as purpose, the selection of seventy-nine (79) young Cameroonians, to benefit from an accompaniment in view of their integration in the transport sector through bike riding.

III. ELIGIBILITY CRITERIA

Can apply, individuals fullfiling the following conditions:

- 1. be a Cameroonian;
- 2. be aged between 17 and 35 years at the time of the candidature;
- 3. reside in Cameroon:
- 4. be registered at the National Youth Observatory (NYO);
- 5. be a holder of Biometric Youth Card;
- 6. be unemployed or in an unfavorable economic situation;
- 7. commit to make use of the vehicle only for professional motives and respect the conditions inscribed within the initiative:
- 8. be in good physical shape: good health, sight, audition and morality.

IV. CANDIDATURE'S FILE

The candidature's file shall comprise the following elements:

- a stamped application to the Minister of Youth Affairs and Civic Education;
- a photocopy of the National Identity Card or a valid receipt otherwise;
- a photocopy of the driving license category A;
- a photocopy of the Biometric Youth Card or the receipt of the said Card;
- a localization plan.

V. DEADLINE FOR THE RECEPTION OF CANDIDATURES FILES

Candidatures files shall be deposited latest on Friday August 29 2025:

- in physical version, in a closed envelop, at 3:30 PM, at the Mail office of the Ministry of Youth Affairs and Civic Education, located opposite the National Archives, or in the Regional, Divisional or Sub-Divisional Multipurpose Youth Empowerment Centers;

VI. <u>SELECTION MODALITIES</u>

Candidatures files received, will in the first place be pre-selected by MINJEC's competent services. The thus preselected shall then be examined by a joint Committee, composed of representatives designated to that effect by MINJEC and those of YUNUS S.A and PEOPLE

Finance S.A. This ad-hoc shall proceed with the evaluation of candidates and the determination of final beneficiaries, in strict compliance with the selection criteria defined in the present Call for Applications. After this evaluation, the selected candidates shall be informed of the decision of the Committee through public posting and/or through electronic means.
